His concerns include, noise, water protection – air pollution. Will the owners follow the guidelines. Mr. Erickson feels if this permit does go through, it is the Boards responsibility to preform due diligence making sure they follow the guidelines to protect the residents of the township.

**Eric Dreczko:** is also concerned with what it may do to the area. Noise, fast traveling trucks on Leo's Road. The Town agreed to put up some speed signs.

**Randy Eytcheson:** Wants to stop the re-zone process. Protect the residents. Would like the board to reconsider their prior approval. The board agreed to place the issue on the February Agenda to reconsider the motion. He wanted the Board to write a letter to Zoning. Chairman Christians said he would personally contact Zoning and inform them that this issue would be on our February agenda.

**Nick Eytcheson:** is concerned it will ruin the opportunity for people to use the ski, horse, trails. The noise would interfere with the enjoyment of riding.
