### PLEDGE OF ALLEGIENCE:

**APPROVAL OF MINUTES:** April 10<sup>th</sup>, 2023 Regular Town Board Meeting Minutes. Supervisor Jack Sjostrom made a motion to approve the minutes as written. Supervisor Poppe 2<sup>nd</sup> the motion. All in favor. 5 yes, 0 no. Motion carried.

**APPROVAL OF COMBINED CLERK & TREASURER REPORTS:** Chairman Christians made a motion to approve the April 10<sup>th</sup>, 2023 report. Supervisor Jack Sjostrom, 2<sup>nd</sup> the motion. All in favor. 5 yes, 0 no. Motion carried.

**PUBLIC INPUT:** Kay Wilson, new Sawyer County Board Member for District 2, visited our township to introduce herself.

**Don Mrotek:** representing the area Snowmobile and ATV Clubs. Mr. Mrotek is concerned regarding the road closing for bike races, will be interfering with the ATV's having access at the same time. **Larry Myhra:** representing the Seeley Lions Club and bike races, explained that the Lions Club uses signage to alert any ongoing ATV traffic that the race is in progress. Both Larry and Don feel they can work together and solve any problems that might arise.

**Fred Cook:** concerned with an issue on Stark road. Board suggested he contact zoning office.

**OLD BUSINESS:** Two items came up at the Annual Meeting [Election Workers Wages and Wood Chipper Purchase] These items will have to be addressed at the budget meeting in October. It was also noted that the property on Ewig Lane has been surveyed, and Chairman Christians has spoken to the appraiser. It is planned that the town may be ready for the sale of said property in June or July.

### ZONING: SAWYER COUNTY ZONING ADMINISTRATION PROPOSED

**ORDINANCE AMENDMENT FOR MULTI-DWELLING DEVELOPMENT OPTION 3 (Version 4.3)** After much discussion Supervisor Bandow made a motion to deny the amendment until some public hearings are held. Supervisor Jack Sjostrom 2<sup>nd</sup> the motion, stating public hearings would allow more input from other parties. All in favor. 5 yes, 0 no. Motion carried

**TOWN OF LENROOT BANKING:** Town Clerk and Town Treasurer requested a change of banking institutions. Their Request is to move the town funds from the Chippewa Valley Bank to the Frandsen Bank of Hayward. Supervisor Jason Sjostrom made a motion to approve the change in banking institutions. Supervisor Bandow 2<sup>nd</sup> the motion. All in favor. 5 yes, 0 no. Motion carried.

**ROAD CONSTRUCTION:** The list of roads for paving and some reconstruction is to be put up for bids as follows: Simons Road – Boedecker Road – Christiansen Road – James Road – Tanning Point/Bullhead Lake Road – Porkys Road Culvert/Mosquito Brook Road – Nelson Lake Park Pavilion Area. Chairman Christians made a motion to seek bids for the above named roads. Supervisor Jack Sjostrom 2<sup>nd</sup> the motion. All in favor. 5 yes, 0 no. Motion carried.

**ROAD & BRIDGE REPORT:** Duck Pond Road wash out has been repaired. Tagalder did have water over the road but is okay now. Parks are all set up for the season and the docks are all put in. Tree trimming in progress.
