APPROVAL OF MINUTES: July 10th, 2023 Regular Town Board Meeting Minutes.

Supervisor Jack Sjostrom made a motion to approve the minutes as written. Supervisor Bandow 2nd the motion. All in favor. 5 yes, 0 no. Motion carried.

APPROVAL OF COMBINED CLERK & TREASURER REPORTS: Supervisor Bandow made a motion to approve the **July 12th, 2023** report. Supervisor Poppe 2nd the motion. All in favor. 5 yes, 0 no. Motion carried.

PUBLIC INPUT: Steve Gonske re: Boedecker /Rustic Road. Mr. Gonske had questions regarding the blacktopping as to how far the town intended to blacktop the road. The town ended the pavement at the pink markers. He was also concerned about the speed limit. It has always been 45 miles per hour. Mr. Gonske also requested a “Hidden Driveway Sign” The chairman will look into the possibility of said sign.
Jennifer Bandow re: The family of Jean Christiansen called her and was concerned about the family headstones at the cemetery and asked Jennifer this to mention to the board. Apparently they also spoke to Jason Sjostrom who has told them that the headstones will be taken care of.

OLD BUSINESS: Porky’s Road Culvert. we now have the Sawyer County Zoning Permit for the culvert on Porky’s Road. Permit is dated good through August 4, 2024, but Chairman Christians has received a 6 month extension bringing the date to February 4th, 2024 which allow for any changed time factor. We are waiting on the DNR permits.

Ewig Road Land Sale: Sale is complete, full payment received \$20100.00.

Silverthorn Lake Ordinance:: Chairman Christians is in the process of creating an ordinance . He asked if the other board members agreed that the statement of “no gas motors allowed on the lake” be included in the new ordinance. They all agreed, and the ordinance will be on the September Agenda.

ACTION ITEM: 2023-2024 Propane Quotes and Approval. Rusk County Farm Supply quoted the lowest price capped at \$1.39.9. Supervisor Bandow made a motion approve the quote from Rusk County Farm Supply. Supervisor Jack Sjostrom 2nd the motion. All in favor. 5 yes, 0 no. Motion carried.

Pat O'Brien representing the Seeley Lions Club and Seeley Hills Outdoor Club: They are seeking permission to build a storage shed next to their ski shelter on Old OO Road. The site that was chosen by them in on the old town dump area. After much discussion it was agreed by all that it would be better to build at another site. Chairman Christians will research for a more feasible area for them to construct their storage shed.

ROAD & BRIDGE REPORT: ROAD Paving will take place on Tuesday & Wednesday. Mowing will start again soon. We repaired washouts on several roads.

TOWN OF LENROOT SEELEY RIVERSIDE CEMETERY: Supervisor Jason Sjostrom said the Christiansen headstones will be placed correctly.
