APPROVAL OF MINUTES: August 14th, 2023 Regular Town Board Meeting Minutes. Supervisor Jason Sjostrom made a motion to approve the minutes as written. Supervisor Jack Sjostrom 2nd the motion. All in favor. 5 yes, 0 no. Motion carried. **May 13, 2023 Cemetery Meeting Minutes.** Supervisor Poppe made a motion to approve the minutes as written. Supervisor Bandow 2nd. Motion. All in favor. 5 yes, 0 no. Motion carried.

APPROVAL OF COMBINED CLERK & TREASURER REPORTS: Supervisor Jack Sjostrom made a motion to approve the **September 11, 2023** report. Supervisor Bandow 2nd the motion. 2nd the motion. All in favor. 5 yes, 0 no. Motion carried.

PUBLIC INPUT: Steve Gonske requested permission to place a “Hidden Driveway “ sign by his driveway. The board had no problem with this. The chairman also stated that the town intends to clear the brush on both sides of his driveway to allow better sight of traffic.

OLD BUSINESS: The Seeley Lions request for an out-building. The chairman has located an area that will be feasible for their building. It should be placed near their current ski shelter building.

ZOOM TV: The equipment for the ZOOM feature on the TV will be soon attached. **DNR Permits:** The permits for the Porky’s Road Culvert Project have been received. Bids for said project should go out in February 2024.

ZONING: Larson Family Property Trust - Town Approval Application. Supervisor Jack Sjostrom made a motion to approve the application. Supervisor Poppe 2nd the motion. All in favor. 5 yes, 0 no. Motion carried.

Dreeg Property LLC - Robert Middlesdorf – Conditional Use Application. Supervisor Jack Sjostrom made a motion to approve the application. Supervisor Bandow 2nd the motion. All in favor. 5 yes, 0 no. Motion carried.

NO ACTION ITEMS:

Discussion of Amendment of Ordinance for Regulating Town Parks. The Board discussed the new ordinance and made only one (1) change, which was to not allow dog owners to let their dogs use the ball field as a dog park.

SUPERVISOR POPPE ISSUES: Issue #1 - concerned about the mowing process. His opinion is that they should make at least five (5) passes each side of every road. Employees doing the mowing should start at 6:00 am in the morning and work that entire day. Chairman Christians and Supervisor Jack Sjostrom, Supervisor Jason Sjostrom and Supervisor Bandow all felt that the employees are doing a good job. Three (3) or more passes are being done, and that should continue. **Issue #2** – A few years ago, Supervisor Poppe had placed a flag bracket and flags on a stop sign near his home. It was removed by town employees. The town does not currently install flags on any signs. Supervisor Poppe wanted his flag bracket back, which was returned to him this day.
