**APPROVAL OF MINUTES: 10 October, 2024 Seeley Riverside Cemetery Committee Meeting.** Supervisor Jack Sjostrom made a motion to approve the minutes as written. Supervisor Jason Sjostrom 2<sup>nd</sup> the motion. All in favor 5 yes, 0 no. Motion carried.

**TREASURER REPORT:** Lenroot Town Clerk Mikula-Stone stated the existing balance is \$418,805.52. Supervisor Jack Sjostrom made a motion to approve the **31 October, 2024** Clerk/Treasurer combined reports. Supervisor Jack Sjostrom made the motion to approve. Supervisor Bandow 2<sup>nd</sup> the motion. All in favor 5 yes, 0 no. Motion carried.

**PUBLIC INPUT:** Ms. Jenny Bandow, Election Supervisor noted the election with very well with a large number of voters participating and some 59 new registrations on voting day. Supervisor Jason Sjostrom highlighted how efficient the all the election volunteers operated on election day finishing their business by about 9:30 in the evening.

Dennis Erickson recognized Ms. Carol Mikula-Stone who is retiring as the Lenroot Town Clerk for her many years of outstanding service for the community.

**OLD BUSINESS:** It was noted that the pile of garbage off the fire lane was picked up, presumably by the county. Lenroot Town Clerk Mikula-Stone turned in her business credit card and keys. A question was asked about the status of Nelson Lake boat landing by the dam,

Chairman Christians stated the work on repairing the boat landing is done and the bottom board in the dam is back in place. Supervisor Jason Sjostrom requested a key for the for the shop.

Supervisor Jack Sjostrom made a motion to approve the American Birkiebeiner Ski Race and use of Lenroot Town hall for the incident command center from **19 February – 22 February, 2025**. Supervisor Danielson 2<sup>nd</sup> the motion. All in favor 5 yes, 0 no. Motion carried.

**New Truck Purchase:** Chairman Christians noted there should be an approval made for purchasing a new truck stating that once we start the process it could take a year before we have the truck. Supervisor Jack Sjostrom made a motion to begin gathering quotes for the new truck. Supervisor Bandow 2<sup>nd</sup> the motion. All in favor 5 yes, 0 no. Motion carried.

**State Retirement System for Lenroot Town Employees:** Chairman Christians identified the opportunity to place Lenroot town employees on the Wisconsin retirement system and it was discussed that the Chairman should begin the resolution inclusion process. **Recognizing Clerk Carol Mikula-Stone:** Chairman Christians recognized Carol Mikula-Stone for her many years of service with a card signed by the board.
