**#2)** Supervisor Jack Sjostrom made a motion to approve the compensation of elected town officials for the term of office beginning April, 2025 through April 2027. Supervisor Danielson 2<sup>nd</sup> the motion. All in favor. 8 yes, 0 no. Motion carried.

**#3)** Chairman Christians made a motion to adopt the 2024 Proposed Town Tax Levy of **\$361,677** to be paid in 2025. Deborah Christians, 2<sup>nd</sup> the motion. All in favor. 8 yes, 0 no. Motion carried. Supervisor Jack Sjostrom made a motion to adjourn the Special Town Meeting of the Electors of the Town of Lenroot. Supervisor Jason Sjostrom 2<sup>nd</sup> the motion. All in favor. 8 yes, 0 no. Motion carried. Meeting adjourned @6:27 pm.
