**COMBINED CLERK AND TREASURER REPORT:** Lenroot Town Treasurer Rebecca Brunner-Stroede stated that the balances between the treasurer and the clerk's accounts balanced and that the existing balance is \$784,954.36. Supervisor Bandow made a motion to approve the Clerk/Treasurer combined reports. Supervisor Danielson 2<sup>nd</sup> the motion. None opposed. Motion carried.

**OLD BUSINESS:** Chairman Christians applied for a TRIS Cost Sharing Grant for redoing Nelson Lake road, but we did not get the grant. Chairman Christians met with member of the Nelson Lake Association to iron out the wording to the Lease agreement pertaining to the storage building by Gerlach Landing.

**Liquor License Application.** TM Lillie LLC. Supervisor Bandow motioned to approve the license. Supervisor Danielson 2<sup>nd</sup> the motion. None opposed. Motion Carried.

**Town Road Adoption Policy.** Chairman Christians proposed to make changes to the Town Road ordinances including the proposal to accept private roads as town roads when graveled as long as they meet all town road standards. This road ordinance will be rewritten and brought up at the meeting in January.

**Town Employee Leave Policy.** New proposal will be 5 days after probation up to one year. 12 days - 1 to 5 years. After 5 years one extra day for each year employed up to 20 years. PTO remains at 1 day earned per month, replacing sick leave. Leave can be carried over two months into the new year. Health policy – proposal: the town workers receive 80% of their premiums covered by the town up to \$8000.00. Chairman Christians made a motion to table this issue until January. Supervisor Bandow 2<sup>nd</sup> the motion. None opposed. Motion passed.
