APPROVAL OF MINUTES: July 2026 minutes Town Board. Supervisor Mittlesdorf motioned to approve, Supervisor Jack Sjostrom 2nd the motion. None opposed. Motion carried.

COMBINED CLERK AND TREASURER REPORT: Lenroot Treasurer Rebecca Stroede noted both the Clerk and Treasurer reports balanced at \$645,667.46.
